SUMMARY:

During the months of June through September of 2025, a total of \$2,660,467.02 in additional contributions were made to the California Asset Management Pool (CAMP). Withdrawals from CAMP totaled \$439,458.36 to pay for various projects including two new Redding Area Bus Authority (RABA) trolleys. Total dividends earned from all CAMP accounts were \$142,104.57.

A total of \$4,723,214.00 in additional contributions were added to the California Cooperative Liquid Assets Securities System (CLASS). Withdrawals totaled \$2,054,889.34 to pay RABA for transit operations and capital projects. Dividends earned from all CLASS accounts totaled \$185,706.21.

STAFF RECOMMENDATION:

It is recommended that the board of directors receive a performance update on SRTA's investment pools for the months ending June 30, 2025, through September 30, 2025.

DISCUSSION:

SRTA holds funds in accounts at two Local Agency Investment Pools (LGIPs): CAMP and CLASS. Each month, a statement of account balances and earned dividends are provided to SRTA. The performance of each account, by month, is detailed below. Detailed summary statements are provided by attachment.

FISCAL IMPACT:

SRTA's policies encourage investing idle funds as much as possible and LGIPs present an opportunity to potentially earn higher return on investments on funds SRTA administers for the region. There is no guarantee on the amount of interest earned on investments in LGIPs, as rates vary and are subject to change by a variety of factors outside SRTA's control. Overall, SRTA saw a return of \$327,810.78 across all accounts, with an average return rate of 4.35% maximizing funding for streets and roads, active transportation, transit, and housing projects.
